The following projects are some of the newest content to be added to our extensive database:

## Adulting

This guide contains a checklist and other information about what to do if a parent, sibling, child, friend, or other loved one passes away unexpectedly and/or without a will. The purpose of this checklist and general guide is to help provide a basic resource for the friends and loved ones of Texans who pass away, expectedly or unexpectedly, without a will (although parts of this checklist will apply even if the deceased has a will). It can be a great starting point for the probate process.

#### **Advocacy Competitions**

To help law students enter the practice with greater advocacy skills, TYLA annually partners with the American College of Trial Lawyers to host the National Trial Competition (NTC). As many as 300 teams from over 150 law schools regularly participate in the competition. TYLA also plans, coordinates, and stages the annual State Moot Court Competition during the State Bar Annual Meeting. TYLA also assists with the annual Paper Chase Competition in partnership with Baylor Law School.

#### **Passing the Bar**

A bar prep study guide that outlines the overall structure of the bar exam to help students get more comfortable with the exam.

#### What Do Lawyers Do

A project designed to help students understand a career in the law before, during, and after law school.
